**RESOLUTION NO. 2017-12**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BIXBY, OKLAHOMA, FORMALLY ADOPTING AUTHORIZED AND EXISTING FEES AND PRESET FINES CHARGED BY THE CITY OF BIXBY, ITS AGENCIES, BOARDS AND DEPARTMENTS, EFFECTIVE JULY 1, 2017.

WHEREAS, the City Council of the City of Bixby has reviewed all fees charged by the City, its agencies, boards and departments and compiled those fees into the attached Exhibit; and

WHEREAS, the costs charged for fees are to ensure the City of Bixby will recover its expenses involved in providing certain services; and

WHEREAS, compilation of all fees and preset fines into one document will better serve the public, will assist employees of the City and will ensure consistent application and review of all fees of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BIXBY, OKLAHOMA THAT:

Section 1. **Fees Established.** The attached Exhibit, with its identified services, fees and preset fines are, by this resolution, now established as fees and preset fines to be charged by the City of Bixby, its agencies, boards and departments for the specific services rendered.

Section 2. **Statutory and Ordinance Fees Prevail.** In the event the amount of any fee or preset fine contained in the attached Exhibit is inconsistent with amounts provided by any state statute or ordinance of the City, then the amount provided by statute or ordinance shall supersede and prevail over amounts contained in the attached Exhibit. To the extent any previous resolution of the City Council provided for the administration and regulation of fees now incorporated into the attached Exhibit, those previous resolutions shall remain in full force and effect as to the administration and regulation of fees, but the fee amounts contained in this resolution shall otherwise supersede any previous resolutions.


Section 3. **City Manager's Authority.** The City Manager is authorized to add any pre-existing and unintentionally omitted fee to the attached list, any fee authorized by the City Council subsequent to the adoption of this resolution and any fee imposed or implemented by other governmental entities, until the next annual review, or to make temporary fee adjustments as special circumstances may warrant, to ensure the City of Bixby will recover its expenses for municipal services rendered. Subsequent to the additions or changes made to the attached list, the City Manager shall publish for access to the public an updated comprehensive fee list as soon as practical

Section 4. **Severability Clause.** If any section, sentence, clause or phrase of this resolution or any part thereof is for any reason found to be invalid by a court of competent

jurisdiction, such decision shall not affect the validity of the remainder of this ordinance or any part thereof.

Section 5. **Effective Date.** The fees adopted by this Resolution and in its attached Exhibit, July 1, 2017 Fee Schedule, shall be effective on and after July 1, 2017.
